Tiny Tennis Policies

Refunds:

If you or your child is not completely satisfied with our program, you may disenroll two weeks after we receive an email or in brief writing explanation of why you are disenrolling from our Tiny Tennis program. Explanation should be submitted no later from the regular scheduled date and time of class. A refund will be issued for ALL unused classes.

Transfer Policy:

If your child disenrolls at current preschool and enrolls at a new one where Tiny Tennis is offered any unused classes will be transferred providing there is an "open spot". A full refund will be issued if Tiny Tennis program is not offered at new center.

Cancellations and Make-ups:

Tiny Tennis reserves the right to cancel or postpone a session due to minimal enrollment.

In the event your child is absent for a class no credit or refund will be given.

In the event Tiny Tennis does not have access to indoor space and outside space is not an option due to inclement weather or at the discretion of the preschool or childcare center a make-up date may be necessary. Tiny Tennis also reserves the right to allow a credit toward a future session. A refund for any cancellations or make-ups are at the discretion of Tiny Tennis.

Time Adjustments:

Tiny Tennis reserves the right to reduce the time of a class from our standard 30 minutes to 20 minutes in the event we deem it necessary in order to make classes smaller in numbers in the event of low enrollment. Currently our classes are made up of 2-3 year olds and 4-5 year olds in conjunction with the preschool or childcare center guidelines for rooms/classes.

NOTE: Tiny Tennis reserves the right to accept any child into our Tiny Tennis program and/or to disenroll a child at any point due to safety concerns.

1. **Consent to Participate.** The undersigned hereby agrees to participate in the "Tiny Tennis" instruction program ("Program"), provided by KLNL Tennis, LLC (d/b/a Tiny Tennis) ("Tiny Tennis"). The undersigned agrees that participation is wholly voluntary. In addition, undersigned has carefully reviewed the information and guidelines regarding the Program and agrees to strictly abide by all terms, conditions and rules contained therein.

2. **Liability Waiver and Indemnification Agreement.** The undersigned, on his or her behalf and on behalf of his or her heirs, administrators, executors, successors and assigns, and anyone claiming by or through the undersigned (collectively, the "Releasing Parties") hereby irrevocably and unconditionally releases, acquits, and forever discharges Tiny Tennis and its members, managers, directors, officers, agents, attorneys, representatives, employees, independent contractors, subsidiaries and related corporations, partnerships and affiliates, successors and assigns (collectively, the "Releasees") from any and all losses, claims, demands, actions and causes of action, obligations, damages and costs or expenses of any nature (including all reasonable expenses of litigation, court costs and attorney's fees) that the Releasing Parties incur or sustain to person, property or both, which arise out of, result from, occur during or are otherwise connected, directly or indirectly, with the Releasing Parties' participation in the Program, or any act or omission, **including negligence by the Releasees**, including without limitation injuries which may occur as a result of the Releasees negligent instruction or supervision or upkeep of the facility or equipment used in connection with the Program.

3. **Medical Release.** The undersigned, on behalf of himself or herself and on behalf of any minor child for whom he or she is responsible, to authorize any medical treatment deemed necessary in the event of any injury or illness while participating in the Program. The undersigned, on behalf of himself and herself and on behalf of any minor child for whom he or she is responsible to pay all costs of any rescue and/or medical services as may be incurred on my/our behalf.

4. **Choice of Law and Forum.** The undersigned, on behalf of himself or herself and the other Releasing Parties, agrees that this Agreement is to be construed under the laws of the Commonwealth of Kentucky. The language of all parts of this Agreement shall in all cases be interpreted as a whole, according to its fair meaning, and not strictly for or against any of the parties. With respect to an action or lawsuit arising out this Agreement or relating to any matter in or referred to in this Agreement, the undersigned, for himself or herself and on behalf of the Releasing Parties, consents to venue being in Jefferson County, Kentucky.

5. **Enforceability/Severability.** The undersigned agrees that this Agreement shall be binding on all of the Releasing Parties and that this Agreement will inure to the benefit of all of the Releasees' successors and assigns. The undersigned further agrees that this Agreement is to be construed broadly to provide a release, indemnification and waiver to the maximum extent permissible under applicable law. Should any provision of this Agreement be declared or determined by a court of competent jurisdiction to be illegal, invalid or unenforceable, the validity of the remaining parts, terms, or provisions shall not be affected thereby and any illegal, invalid or unenforceable part, term or provision shall be deemed not to be a part of this Agreement.

IN SIGNING THIS DOCUMENT, THE UNDERSIGNED ACKNOWLEDGES THAT IT HAS READ THIS ENTIRE DOCUMENT, AND FULLY UNDERSTAND ITS TERMS. THE UNDERSIGNED UNDERSTANDS THAT, BY SIGNING THIS AGREEMENT, IT IS GIVING UP RIGHTS THAT IT MIGHT OTHERWISE HAVE, INCLUDING A CLAIM AGAINST THE RELEASEES FOR, AMONG OTHER THINGS, NEGLIGENCE, AND THAT IT HAS SIGNED THIS AGREEMENT KNOWINGLY AND VOLUNTARILY AS TO ITS CONTENT AND INTENT. THE UNDERSIGNED HAS READ AND SIGNED THIS AGREEMENT AND FURTHER AGREE THAT NO ORAL REPRESENTATIONS, STATEMENTS, OR INDUCEMENT APART FROM THE FOREGOING WRITTEN AGREEMENT HAVE BEEN MADE. A photocopy of this Agreement is as valid as the original.
